The winner will be determined based on the highest percentage of intake from December 1 to December 24. In the spirit of giving, we encourage the winners to donate their prizes to the council's favorite charity or to members of the council who are in need.

Finally, the Supreme Council is also doing its share of giving. The Supreme Knight just announced that the per capita credit for councils achieving the Star Council award will continue. That means \$4.50 credit for each billable member of your council. So, let's shoot for the star and make your council a Star Council in this fraternal year.

#### A KNIGHT BEFORE CHRISTMAS

Give the gift of Knights of Columbus membership this Christmas! Use any holiday celebrations your council sponsors to tell qualified men about the Order and ask them to join. Sponsor a reception, an evening of caroling or a similar event and invite nonmembers to attend. Have Knights of Columbus promotional flyers and posters on hand. Also, show one of the Order's promotional Videos.



If your council is planning a Christmas social or similar activity, set a date and time for the event well in advance to ensure a positive turnout from your council and their family members. Be sure and invite your pastor and other members of your parish and the Catholic community. Recruit volunteers from your council to set up for the event, run activities, serve food, clean up, etc. Be sure to consider all the details of your event. Will it be a sit-down meal or a standing social with a variety of snacks? What about advertising? Announce your event at Mass and in church bulletins to spread the word to all possible prospects. Plan entertainment for both adults and children. Contests, raffles, sing-a-longs and holiday videos are just the type of things to keep the families of both council members and prospects entertained.

To get prospects and their families interested in the Order, have display materials and items that show your council's history and the various types of projects you conduct. Have plenty of recruitment flyers and other information on hand. Pamphlets are perfect for prospective members to quickly read while at your event, sparking interest and generating a desire to learn more about the Order. Also, have a supply of Membership Documents (Form 100s) available for interested prospects.

Along with members and prospects, invite former and inactive members and their families. Ask for assistance from your Financial Secretary, Past Grand Knights and Trustees in collecting information about these former members and the circumstances of their leaving the Order. Review the list to determine which former members still live in your area and invite them to your celebration.



Finally, ask prospects to attend a council volunteer effort — such as an evening of working in a soup kitchen, cleaning the church, or a clothing and food drive for needy families to show prospects firsthand what the Knights of Columbus does for the Church and the community. Schedule an Admissions Degree during Advent so it truly is a "Gift of Membership."

In all that your council does, share the joy and spirituality of this very special time of year. On behalf of the California State Council — have a very merry Christmas!



#### MEMBER RETENTION

My Brothers,

Scriptures tell us of how we should be caring of our fellow man. This is especially true for Brothers of our Order. I draw your attention to Luke 15: 3-7 (the parable of the lost sheep) and to John 10: 1-17, Mathew 9:36 and Mark 6:34 in which Jesus explains His role as Shepherd. In John 21: 15–17, Jesus transfers the care of his flock to Peter, the Founder and Corner Stone of the Holy Catholic and Apostolic Church. So, if we Brother Knights are to also be Apostles like Peter, we must be willing to be Worthy Shepherds who CARE about our members and WORK to keep our Brother Knights in the Order.

There are several tools at a council's disposal that are helpful in easing the burden for those with extenuating circumstances, or who are having a hard time paying council dues:

- Knights with a medical disability may be eligible for a Disability Waiver from Supreme, suspending all State and Supreme per capita assessments. The council can apply for the waiver using Supreme Form #1831, available on the Supreme web site at https://www.kofc.org/un/en/forms/council/dues\_relief\_1831\_p.pdf
- Elderly or senior members living on a fixed retirement income may be eligible for
   Honorary or Honorary Life Membership, depending upon their age and years of
   continuous service. Those 65 years or older with 25 or more consecutive years of service
   in the Knights of Columbus are eligible for Honorary Membership, relieving State and
   Supreme assessments and reducing their council dues to a minimal rate (usually \$10.00
   per year). Those 70 years or older with 25 years of consecutive service are relieved of
   all state and supreme assessments and exempt from payment of all council dues.
- In matters of extreme financial hardship and/or extraordinary circumstances, the council, at its discretion, may waive the dues for a member found to be in distress or difficulty or another Brother may volunteer to pay for him.

Regardless of the method or situation, it is important the Retention Committee investigate and report the circumstances of every member in arrears, and recommend a suitable course of action or solution for each one.

## "Remember, personal contact is the key"

Every Knight, regardless of the circumstances, deserves the dignity and consideration afforded by our Order, faith, Christian charity and belief in the Holy Catholic Church. It is important that every member feel he is a NEEDED, IMPORTANT, INVOLVED and a CONTRIBUITING MEMBER of our organization. Through our united efforts to retain current members as well as recruiting new ones, we will keep our Order strong and growing.

### FREE THROW COMPETITION

Since 1972, councils have sponsored the Knights of Columbus International Free Throw Championship for boys and girls between the ages of 9 and 14. The championship is set up to have the contestants compete within their own gender and age group. All competition starts at the local level. Winners move on to the district, chapter/regional, and state levels. From there, some make it to the international level for championship competition in their group.

To sponsor a competition, all your council needs is the *Free Throw Championship Kit (#FT-KIT)*, a couple of basketballs, a hoop and a bunch of kids. It is a great way to get out into the public and introduce the Order to your community — while providing youths with a rewarding activity that yields a chance for local, state or provincial, and international recognition.

You can also use the order form in the *Council Report Forms Booklet* (#1436), or call the Department of Fraternal Services at 203-752-4270.

#### Who May Enter?

All boys and girls between the ages of 9 and 14 are eligible to compete in the Free Throw Championship. Age eligibility is determined by the age of the contestant as of January 1. High school-age athletes should be advised to check with their school athletic directors or their state's high school athletic association regarding possible eligibility conflicts. Each youngster may compete in only one council competition. Local champions may not represent more than one council.

Championship entrants compete against youngsters of the same age and gender in six age divisions: 9, 10, 11, 12, 13 and 14. At the council level, each competitor gets 15 free throws, and the one who makes the most shots wins. If there's a tie, five-shot tiebreaker rounds follow until a winner emerges. Use a tiebreaker if there is a tie for second place; the second place finisher will move on to successive levels of competition if, for whatever reason, the winner is unavailable. In the event that the winner in any level cannot participate in the next level of competition, the second place winner should represent the area group.

All contestants must register using the official K of C Free Throw Championship Entry Form/Score Sheet (#1598). All entry forms/score sheets must include a parent's signature. Proof of age must accompany all registration forms and should be verified at all levels. The entry form/score sheet also contains spaces to record the contestants' scores. This form must accompany each champion as he or she progresses through the competition.

Council Free Throw Competitions will be held on January 2017, District and Chapter Competitions on February 2017, and the State Free Throw Competition on March 18, 2017 (Saturday) at one location in Northern California and another one in Southern California. Locations will be at: North – Vacaville and South – Rancho San Antonio.

Council endorsement resolutions must be signed by the council Grand Knight and Recording Secretary and have the council seal affixed.

The original <u>must</u> be mailed to the State Office. To avoid typographical errors in retyping resolutions for printing, it is strongly recommended that an electronic copy of the resolution also be provided. E-mail to: state.office@californiaknights.org

This year, 'Council Endorsements' will be mailed with the 'Resolutions' booklet that is mailed to each council 45 days prior to the annual State Meeting. If you have any questions, please call the State Office at 909-434-0460.

#### Guidelines for Elections:

- A candidate may prepare a short biography which may be featured on the State Council's web site.
- If a candidate's council passes a resolution of support for a particular candidate, that resolution can be disseminated to the other councils within the candidate's jurisdiction.
- A candidate may not mass mail (either US Mail or e-mail) members of the Knights of Columbus or the general public.
- In the event a candidate's council passes a resolution in support of a particular candidate, that resolution
  can also be posted on the State Council's web site.

The McGivney Legacy





Father Michael J. McGivney was a 29-year-old assistant pastor at St. Mary's Church in New Haven, Conn., when he founded the Knights of Columbus in 1882. Father McGivney's holiness, devotion to priestly ministry and work to protect family life provide a powerful spiritual influence for Knights of Columbus, their family members and a growing number of other Catholics.

Father McGivney's cause for canonization was opened in 1997 by then Archbishop Daniel A. Cronin of Hartford, Conn. Its diocesan phase has been completed. The Congregation for the Causes of Saints at the Vatican is currently reviewing Father McGivney's life and works and investigating two reported miracles attributed to his intercession.
