WHEREAS, Brother John Doe has served the California State Council as State Committeeman under the State Membership Committee as Assistant Chairman-North for New Council Development/Round Table, State Membership Coordinator and Committeeman for two (2) years in the State Council's Administrative and Finance Committee; served as 2010 State Convention Assistant Chairman, and 2012-2013 Awards Program Chairman; and

WHEREAS, Brother John Doe has served four (4) years as the District Master for the California District, St. Junipero Serra Province of the Knights of Columbus Fourth Degree; formed one new assembly, Second Catholic Church Assembly 456 in Another City, California; and

WHEREAS, Brother John Doe is an active parishioner of First Catholic Church in Somewhere City serving as a Eucharistic Minister, Lector, and Hospitality Minister; was a member of the Parish Finance Council for seven (7) years, served as Chairman in the Leadership Phase of the Capital Campaign of the Parish; and

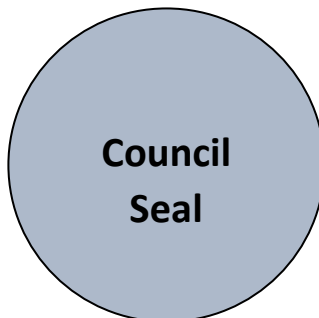
WHEREAS, Brother John Doe has retired from Somewhere City, California where he worked as a Public Servant for 36 years.
