WHEREAS, Patrick E. Kelly assumed responsibility on March 1, 2021 to serve as the fourteenth Supreme Knight of the Knights of Columbus and serves as the Chief Executive Officer and Chairman of the Board of Directors, leading more than 2 million members and their families; and

WHEREAS, as a member of the knights of Columbus since 1983, Patrick E. Kelly has a distinguished career in the Knights of Columbus, the military and public service which will serve him well in advancing the Orders mission of Charity, Unity, Fraternity and Patriotism; and

WHEREAS, Patrick E. Kelly has served as Deputy Supreme Knight since 2017 and has also served as the first executive director of the Saint John Paul II National Shrine in Washington, D.C. and oversaw the renewal of the facility after its purchase by the Knights in 2011; and

WHEREAS, Patrick E. Kelly has served as a consultant to the committee on Pro-life Activities, the Committee on Religious Liberty, and the Subcommittee for the Promotion of Defense and Marriage of the U.S. Conference of Catholic Bishops for more than a decade; and

WHEREAS, Patrick E. Kelly has been the Chairman of the Board of Directors of the March for Life since 2012, which under his leadership the March for Life has become one of the most effective pro-life organizations in the world; and

WHEREAS, Patrick E. Kelly holds a master's degree in theology from the Pontifical John Paul II Institute for Studies on Marriage and Family at The Catholic University of America, a law degree from Marquette University Law School and bachelor's degree in economics from Marquette University; and

WHEREAS, Patrick E. Kelly served in the United States Navy for 24 years, on land and sea, on active duty and reserve status. As a Judge Advocate General, he specialized in international and operational law and served as the Commanding Officer of the international law unit at the U.S. Naval War College. His personal awards include three Navy Achievement Medals, five Navy Commendation Medals and the Meritorious Service Medal.

WHERE AS, Archbishop Lori was consecrated as a bishop on April 20, 1995 in the Archdiocese of Washington; and

WHEREAS, Archbishop Lori in March 2001, was appointed Bishop of Bridgeport by Pope John Paul II; and

WHEREAS, Archbishop Lori was elected Supreme Chaplain of the Knights of Columbus in April 2005; and

WHEREAS, Archbishop Lori was appointed Archbishop of Baltimore by Pope Benedict XVI, assuming the role as the 16th Archbishop upon installation on May 16, 2012; and

WHEREAS, Archbishop Lori has been a member of the Pro-Life Activities and the Committee on Doctrine of the U.S. Conference of Catholic Bishops; and

WHEREAS, Archbishop Lori as one of four U.S. bishops on a special Mixed Commission, journeyed to the Vatican to revise the "Essential Norms" of the Charter, which has now become particular law for the Catholic Church in the United States to ensure that no one who works for the Catholic Church will ever pose a threat of any kind to any person, young or old; and

WHEREAS, Archbishop Lori has worked closely with the Supreme Knight in highlighting the role of Knights of Columbus chaplains at every level of the Order.

RESOLUTION - IN DEFENSE OF RELIGIOUS LIBERTY 2023

WHEREAS, the Second Vatican Council declared in Dignitatis Humanae that the right to religious freedom is based upon the inherent dignity of the human person, which requires that all people are to be free from coercion in matters of belief and conscience, and that no one should be forced to act in a manner contrary to his or her own beliefs or conscience; and

WHEREAS, the right to religious freedom is guaranteed by the First Amendment of the Constitution of the United States, the Canadian Charter of Rights and Freedoms, the Universal Declaration of Human Rights, and other documents recognizing religious freedom; and

WHEREAS, religious freedom is not a benefit that a government confers out of a sense of mere tolerance, which can be removed, but rather it is an inalienable right, rooted in the transcendent dignity of every human being; and

WHEREAS, Pope Francis has called religious freedom "a fundamental right of man," that is "not simply freedom of thought or private worship" but "the freedom to live according to ethical principles, both privately and publicly;" and

WHEREAS, since its founding, the Knights of Columbus has worked to defend religious freedom for all people and has done so out of a commitment to our faith and our unshakeable belief that religious freedom is a basic human right; and

WHEREAS, the Order's work on behalf of religious freedom included efforts in the U.S. Supreme Court case Pierce v. Society of Sisters, which affirmed the right of children to a Catholic education in opposition to the efforts of the Ku Klux Klan; and

WHEREAS, our work for religious freedom also included protesting the persecution of Catholics in Mexico in the 1920s; efforts to combat the anti-religious worldview of Communism; and the inclusion of the phrase "under God" in the U.S. Pledge of Allegiance to distinguish the United States from anti-religious governments; and

WHEREAS, Pope Francis has urged the Knights of Columbus to draw the attention of Catholic Americans "to contribute to the reasoned defense" of religious freedom and reminded us that "to the extent that this right is menaced...there is a need for a mobilization of consciences on the part of all those citizens who, regardless of party or creed, are concerned for the overall welfare of society."

NOW THEREFORE BE IT RESOLVED, that we will remain steadfast in our support for the free exercise of religion as it is described in Dignitatis Humanae and enshrined in the Universal Declaration of Human Rights and other documents recognizing religious freedom; and

FURTHER RESOLVED, that we stand firm in our conviction that the full guarantee of religious liberty cannot be limited to "freedom of worship" as some have claimed, but must include full "freedom of religion," which necessarily encompasses the public dimension of religion, the freedom from persecution or discrimination on the basis of conscience and belief, and the fact that believers are called to play an active role in building the social order; and

FURTHER RESOLVED, that we call on the U.S. Department of Justice, U.S. Department of Health and Human Services, and U.S. Department of Education to maintain robust religious and moral exemptions as part of its regulatory rulemakings and enforcement of federal law; and

FURTHER RESOLVED, that we urge all government officials to enact legislation that will protect the right of religious institutions and individuals to be free from government coercion; and

FURTHER RESOLVED, that we will always speak out against any effort to impose religious tests on candidates or nominees for government positions; and

FURTHER RESOLVED, that we will remain steadfast in our opposition to future governmental actions or policies that force institutions and individuals to violate their deeply held religious beliefs. and

BE IT FURTHER RESOLVED, that the delegates to the Knights of Columbus 121st California State Annual Meeting in Ontario. CA held on May 19 - 20, 2023, pledge their support in the defense of Religious Liberty in the USA; and

NOW BE IT FURTHER RESOLVED, that the State Secretary be directed to forward a certified copy of this resolution to the Supreme Secretary for consideration by the delegates to the 141st Supreme Council meeting to be held in Orlando, FL, August 1 - 3, 2023.

RESOLUTION - IN SOLIDARITY WITH UKRAINE 2023

WHEREAS, at the 123rd Supreme Convention held in Chicago in 2005, the late Major Archbishop of Kyiv-Halyč, His Eminence Lubomyr Cardinal Husar, expressed his fervent desire that the Knights of Columbus be established in Ukraine to provide the Catholic men of his country the proper formation to serve the Church as lay leaders; and

WHEREAS, in May 2012 His Beatitude Sviatoslav Shevchuk, Major Archbishop of Kyiv-Halyč and head of the Ukrainian Greek Catholic Church, and His Excellency Mieczysław Mokrzycki, Roman Catholic Archbishop of Lviv, joined the Knights of Columbus during historic First and Second Degree ceremonies in Ukraine, conveying the message of charity and unity that has become the essential hallmark of the Order's development in Ukraine; and

WHEREAS, in 2016 the Board of Directors established Ukraine as a territorial jurisdiction of the Order and, two years later in 2018, established Ukraine as a state council which today has more than 1,900 members across 44 local councils; and

WHEREAS, on February 24, 2022, the largest refugee and humanitarian crisis since the Second World War erupted in Europe, sparked by the outbreak of violent conflict in Ukraine, which Pope Francis has decried as an "abhorrent war;" and

WHEREAS, on February 25 Supreme Knight Patrick Kelly delivered a message of hope and unity to the Knights and families of Ukraine pledging that the Supreme Council, and all brother Knights, would stand with them and announced the creation of the Ukraine Solidarity Fund which, to date, has raised more than \$18 million in direct aid for Ukrainians; and

WHEREAS, the Supreme Council partnered with Knights in Poland and Ukraine and immediately established Mercy Centers on the border of the two countries to respond to the ensuing humanitarian crisis, which has seen more than six million Ukrainians flee their country; and

WHEREAS, while the immediate need at the border was abating, Polish Knights quicky pivoted by establishing Mercy Centers in parishes throughout Poland to provide aid, shelter, and resources to displaced Ukrainians; and

WHEREAS, Polish and Ukrainian Knights have continued to partner via KofC Charity Convoys to relay thousands of pounds of food and other humanitarian supplies from Poland into Lviv, and then around the war-torn country; and

WHEREAS, the Supreme Knight traveled to Ukraine and Poland during Holy Week to meet with brother Knights and their families to personally express the Order's solidarity with them and to thank them for all of their efforts, including the distribution of more than 10,000 Easter baskets containing food and supplies to those in need; and

WHEREAS, in a private audience with the Supreme Knight, Pope Francis expressed his heartfelt support for the Order's efforts in Ukraine, extolling all Knights to continue this important mission with the simple charge: "Go on! Go on!"

NOW, THEREFORE, BE IT RESOLVED, that the Knights of Columbus reaffirms its solidarity with the people of Ukraine as they courageously confront an ongoing humanitarian crisis; and

FURTHER RESOLVED, that the Knights of Columbus calls for an immediate end to all hostilities and for full and unfettered access to humanitarian assistance for all affected civilians, especially children, the elderly, people with disabilities, and the most vulnerable; and

FURTHER RESOLVED, that we offer deep appreciation to the Knights of Poland who have provided countless hours of support to the Ukrainian people by responding to the humanitarian crisis as Knights have responded to similar periods of unrest and war for 140 years—through charity on the frontlines that seeks to provide aid and comfort for those most impacted and those most in need; and

FURTHER RESOLVED, that we commend the Knights of Ukraine for their unwavering commitment to Charity, Unity, Fraternity, and Patriotism amidst the perils of the present conflict during which they have answered the call of Cardinal Husar to "raise the spirituality" of their people and "show them the real face of the Church...as it should be;" and

FURTHER RESOLVED, that we call on the United Nations, the European Union, and all people and nations of goodwill, to respond in whatever way they are able to support the suffering people of Ukraine; and

FURTHER RESOLVED, that we recommit ourselves to answering the call of Pope Francis to pray for peace in Ukraine, and across all of Eastern Europe, and to continue providing support to those impacted by the conflict through our Ukraine Solidarity Fund and the ongoing daily corporal works of mercy performed by our brother Knights throughout Eastern Europe; and

BE IT FURTHER RESOLVED, that the delegates to the Knights of Columbus 121st California State Annual Meeting in Ontario. CA held on May 19 - 20, 2023, pledge their support of Ukraine; and

NOW BE IT FURTHER RESOLVED, that the State Secretary be directed to forward a certified copy of this resolution to the Supreme Secretary for consideration by the delegates to the 141st Supreme Council meeting to be held in Orlando, FL, August 1 - 3, 2023.

RESOLUTION - IN SUPPORT OF THE NATIONAL EUCHARISTIC REVIVAL 2023

WHEREAS, the Catechism of the Catholic Church teaches that the Eucharist "is the source and summit of the Christian life," and that all the sacraments and works of the Church are, "bound up with the Eucharist and are oriented toward it. For in the blessed Eucharist is contained the whole spiritual good of the Church, namely Christ himself;" and

WHEREAS, a September 2019 study by the Pew Research Center found that 70% of U.S. Catholics either do not accept, or do not fully understand, the Church's teaching that the Eucharist is "the body and blood, together with the soul and divinity, of our Lord Jesus Christ;" and

WHEREAS, Mass attendance in the United States has been declining for the past several years and suffered even further following the abatement of the COVID-19 pandemic; and

WHEREAS, in response to these realities, and recognizing a clear need and opportunity to evangelize all people, the United States Conference of Catholic Bishops announced a three-year National Eucharistic Revival which will include spiritual and catechetical programs at the parish and diocesan levels; and

WHEREAS, in 2021, Supreme Knight Patrick Kelly called on all brother Knights to be Knights of the Eucharist and committed the Order to fully supporting the National Eucharistic Revival; and

WHEREAS, the Supreme Council has developed resources to support this initiative including: The Eucharist: Source of Our Healing and Hope, an inspirational and catechetical video about the gift of Christ's Real Presence; videos explaining the significance of various portions of the Holy Mass; and, resources demonstrating how to properly host eucharistic processions which will be the marquee events of the revival over the next three years

NOW, THEREFORE, BE IT RESOLVED, that the Knights of Columbus fully commits itself to Eucharistic renewal throughout the Universal Church by answering the Supreme Knight's call to be Knights of the Eucharist; and

FURTHER RESOLVED, that we are fully committed to the National Eucharistic Revival in the United States and will support programs sponsored by our parishes and dioceses; and

FURTHER RESOLVED, that we will host Eucharistic Processions in the communities we serve so as to provide a special witness to the power of Christ's Real Presence and the hope that it will inspire a new fervor in all of God's people and an atmosphere of charity and peace in communities throughout the world; and

BE IT FURTHER RESOLVED, that the delegates to the Knights of Columbus 121st California State Annual Meeting in Ontario. CA held on May 19 - 20, 2023, pledge their support of the Eucharist Revival; and

NOW BE IT FURTHER RESOLVED, that the State Secretary be directed to forward a certified copy of this resolution to the Supreme Secretary for consideration by the delegates to the 141st Supreme Council meeting to be held in Orlando, FL, August 1 - 3, 2023.

RESOLUTION BUILDING A CULTURE OF LIFE 2023

WHEREAS, the Knights of Columbus has a deep and historic commitment to oppose any government action or policy that promotes abortion, embryonic stem cell research, human cloning, euthanasia, assisted suicide, or other offenses against life; and

WHEREAS, the Order supports programs that provide women facing crisis pregnancies with alternatives to abortion, including adoption, and that we support projects that provide spiritual support to those women suffering from the traumatic emotional and psychological aftereffects of abortion; and

WHEREAS, our Ultrasound Program has provided a window into the womb by placing nearly 1,600 ultrasound machines in 50 states, the District of Columbia, the Republic of Korea, and a growing number of Canadian provinces; and

WHEREAS, in July 2022 the Supreme Council launched the Aid and Support After Pregnancy (ASAP) Program to support the hundreds of pregnancy resource centers and maternity homes—collectively serving nearly two million expectant mothers, parents, and babies in the United States—by providing \$100 for every \$500 that a council gives in support of such facilities; and

WHEREAS, we reaffirm our commitment to building a "culture of life" by promoting policies that favor the family, and by recognizing that it is within strong and healthy families that moral values are taught and the spiritual heritage of the nation is transmitted; and.

WHEREAS, the Knights of Columbus has a long history of supporting marches and rallies for the cause of life in the countries where we have a formal presence; and

WHEREAS, Pope Benedict XVI reiterated that "Catholic politicians and legislators, conscious of the grave responsibility before them, must feel particularly bound, on the basis of a properly formed conscience, to introduce and support laws inspired by values grounded in human nature;" and

WHEREAS, in his apostolic exhortation Evangelii Gaudium, Pope Francis reminded us that, "Among the vulnerable for whom the Church wishes to care with particular love and concern are unborn children, the most defenseless and innocent among us...this defense of unborn life is closely linked to the defense of each and every other human right. It involves the conviction that a human being is always sacred and inviolable, in any situation and at every stage of development;" and

WHEREAS, in his encyclical, Laudato Si', the Holy Father reiterated that "Since everything is interrelated, concern for the protection of nature is also incompatible with the justification of abortion;" and

WHEREAS, in remarks to the leadership of the United States Conference of Catholic Bishops, Pope Francis reiterated that "protection of the unborn is a preeminent priority" and it is not first a religious issue, but rather an issue of human rights.

NOW, THEREFORE BE IT RESOLVED, that we will continue to speak out to our elected representatives about the need to enact legislation protecting human life in all its stages; and

FURTHER RESOLVED, that we believe women deserve better than abortion and will continue to support alternatives to abortion, including adoption, and that we support projects which provide spiritual support to those women and men suffering from the traumatic emotional and psychological aftereffects of abortion; and

FURTHER RESOLVED, that through our Ultrasound Initiative and the ASAP Program, we will continue to support pregnancy care centers and maternity homes so that they can provide the necessary resources and support that help mothers to choose life and both rear and care for their children; and

FURTHER RESOLVED, that the Knights of Columbus will continue to uphold the Catholic Church's authoritative teaching on the sanctity of life from conception to natural death, as explained in the Catechism of the Catholic Church, Laudato Si', and other documents; and

FURTHER RESOLVED, that we reaffirm our long-standing policies of not inviting to any Knights of Columbus event, persons, especially public officials or candidates for public office, who do not support the legal protection of unborn children, or who advocate the legalization of assisted suicide or euthanasia, and that we prohibit such persons from renting or otherwise using facilities over which our members have control, or speaking at Knights of Columbus events, or bestowing on them honors or privileges of our Order of any kind, or inviting them to serve as honorary chairpersons of events, celebrations, or committees, or hold any office in the Knights of Columbus; and

FURTHER RESOLVED, that we once again commit ourselves to praying the Rosary frequently, to fasting and to doing penance in reparation for the evils perpetrated against the gift of life and that we seek the intercession of the Blessed Virgin Mary, who herself said "yes" to life, to intercede on our behalf for the establishment of a "culture of life."

WHEREAS, Brother Rene Trevino served as State Secretary in CY 2021-2022, State Treasurer in CY 2020-2021, State Advocate in CY 2019-2020, State Warden in CY 2018-2019, State Operations Director for two consecutive terms in 2016-2018 and was recognized as the **Knight of the Year** in CY 2016-2017; and Special Olympics World Games Chairman (South) in 2014-2015 where he assisted in coordinating services with the World Games organization and was a group leader for the World Games Track and Field events; and

WHEREAS, Brother Rene Trevino and his lovely wife Carla have been active in the Council, Chapter and State, especially the Annual Widows and Widowers Luncheon hosted by the San Diego Chapter, created by Lady Carla, that recognizes those family members who lost a Brother Knight or a Brother Knight who lost a spouse; and

WHEREAS, Brother Rene Trevino has served Saint Gregory the Great Parish for the past 18 years. He is an Extraordinary Minister of Holy Communion, Former Parish Lector Facilitator, Altar Server, Bible Study cofacilitator with Carla, and serves on the Parish Development Steering Committee where he provides his architectural and contract expertise reviewing various projects to include parish hall expansions, new school development and installation of solar panel carports.

NOW, THEREFORE, BE IT RESOLVED, that in view of his service, dedication, demonstrated leadership to the Knights of Columbus, and in service to the Council, Chapter, State, Church and Community, the California State Council proudly and enthusiastically endorses Brother Rene Trevino for election to the Supreme Board of Directors and urges his endorsement at the California Annual State Council Meeting to be held in May 2023.



Resolution of endorsement for Dr. Raymond F. Warriner as Supreme Director



WHEREAS, Charity is the first principle of our order and he lives that principle. Brother Ray is President Emeritus of the Californian Columbian Charities, Inc. During his 10 years as President, he revamped its application process to greatly reduce processing times, personally reviewed all applications, dealt directly with the Council's Grand Knights to resolve issues, and expedited assistance to our brothers.

WHEREAS, Brother Ray is a dynamic and motivated leader that uses his talents to advance the Order in many ways. As State Intellectual Disabilities Chairman and President of the Frank Nigro Columbian Foundation, his management skills and leadership has turned the declining support for California's largest service program into record donations not seen for at least a decade. California has raised almost \$3 M for Intellectual Disabilities since Brother Ray assumed the leadership six years ago. As State Special Olympics Chairman, he partnered with Special Olympics, which increased both financial support and volunteer opportunities for Knights. This includes over \$80,000 raised and hundreds of volunteer hours at Special Olympic events.

WHEREAS, Brother Ray was the General Bernard A. Schriever Chapter of the Air Force Associations - Kathleen L. Landis Volunteer of the Year recipient for 2016 & 2020 resulting from his many years of community service especially his work with Special Olympics World Games.

WHEREAS, A "2013 Circle of Honor" State Deputy, Brother Ray introduced a teaming relationship with the General Agents to grow the Order. This resulted in 4,532 men joining, a new record for California, 65 Star Councils, 19 new Councils and the reactivation of 12 others.

WHEREAS, Brother Ray introduced the concept of actionable data. This included a monthly report to every council measuring progress toward Star Council (Star Tracker) and a report tracking the progress of each District Deputy referred to as the DD Shield Report.

WHEREAS, California, under Brother Ray's leadership set new records for programs. This included over \$300,000 for Wheelchairs including 1,000 wheelchairs to the Philippines and 300 wheelchairs to Veterans (featured in Aug 2013 issue of Columbia). Over \$93,000 for Special Olympics program and over 17,000 volunteer hours and over \$650,000 for People with Intellectual Disabilities. California programs were also recognized with "Living Bethlehem" as 2nd Place in the International Church Award category.

WHEREAS, California, under Brother Ray's leadership hosted both the 2012 Supreme Convention and Guadalupe Celebration. The Celebration of the Patroness of America and the Mother of God filled Los Angeles Memorial with around 75,000 people including national and international celebrities.

WHEREAS, Brother Ray has served the Catholic Church since being baptized in 1978. He became a Eucharistic Minister for the USAF in 1979 and continues in that role today. In 1995 Brother Ray took over St. Bernard Children's Liturgy program and shares the liturgy with the most impressionable of Catholics - our children.

WHEREAS, Patriotism is the fourth principle of our order. Brother Ray has and continues to serve the Nation as a retired Air Force Officer and is working to develop secure communication for the Department of Defense. While many of his classmates were looking for ways to avoid the draft, he enlisted in 1971, as a high school senior and served his nation like his father before him. He served over 21 years, from the time of Viet Nam to the Operation Desert Storm in 1990. After retiring in 1992, he was asked to return to serve the nation as advisor on matters related to military satellite communications. He served over 25 years in that position. In May of 2019, he became the Chief of Engineering and Integration for Satellite Communications Capabilities for what would become the United States Space Force. He is currently the Chief Engineer for Military Satellite Communications systems. Ray has both degrees in Engineering and Management that is put to use daily for the Church, community and country.

NOW, THEREFORE, BE IT RESOLVED, in view of his service and dedication to the Knights of Columbus, our council, the Catholic Church and the Nation. The Mary Help of Christians Council 3052 proudly and enthusiastically endorses Raymond F. Warriner for the office of Supreme Director and urges California State Council endorsement at the annual convention to be held in Ontario, California in May 2023; and

BE IT FURTHER RESOLVED that the State Secretary be directed to forward a certified copy of this resolution to the Supreme Secretary for consideration by the delegates to the Supreme Council meeting to be held in Orlando, Fl in August 2023.
