RESOLUTIONS

- All council resolutions must be into the state office postmarked no later than **THURSDAY, FEBRUARY 1, 2024.**
- Council resolutions must be dated, signed by the council grand knight and recorder and have the council seal affixed.
- Purposes of resolutions for vote at the Annual State Meeting
 - Congratulatory in nature, State Council governance, candidacy for office

HOME CORPORATIONS

- Home corporations are **NOT** subordinate units of the Knights of Columbus.
- The Home Corporations are solely responsible for all liabilities arising from the properties and the activities conducted there.
- Councils using home corporation facilities are required to enter into written agreements governing:
 1. A council's use of home corporation facility, and
 2. How matters will be settled between the council and the home corporation upon dissolution of the home corporation.

Council Liability

- Knights of Columbus does **NOT** provide insurance for local councils
 - Each council must arrange for its own insurance coverage
 - Knights of Columbus does not provide insurance for home corporations
 - Dioceses often require proof of insurance for councils using their facilities, and be named on the rider
 - Diocesan requirements often specify particular coverage and limits

- Councils must arrange for their own coverage
Desired protection includes:
 - General liability
 - Director and Officer liability
 - Liquor liability
 - Sexual abuse liability
 - COVID exposure liability
