## THE CONSENT CALENDAR

**<u>PURPOSE:</u>** The Consent Calendar is a parliamentary procedure used to deal with non-controversial resolutions, without debate and without voting.

**<u>USE:</u>** All resolutions are initially placed on the Consent Calendar.

Each resolution is called and all non-controversial resolutions remain on the calendar to be automatically accepted or rejected in accord with the recommendation of the Resolutions Committee. All other resolutions are removed from the Consent Calendar for review and debate prior to being voted on.

**PROCEDURE:** Initially the Chairman of the Resolutions Committee will call each resolution by number and title only, also reading the recommendations of the Resolutions Committee. If there is no objection from the convention floor the Resolution will remain on the Consent Calendar and the recommendation of the Resolution Committee will be the action of the State Council on said resolution.

If there is an objection to the recommendation of the Resolutions Committee or if a delegate wishes to discuss the resolution, he should approach one of the floor microphones, identify himself by name, council name and number and delegate status. He should then state, "I wish to have this resolution removed from the Consent Calendar", or simply state, "Objection". The resolution will then be removed from the Consent Calendar without discussion.

The resolutions remaining on the Consent Calendar at the end of the review will be accepted or rejected according to the recommendation of the Resolutions Committee. Those resolutions removed from the Consent Calendar will be opened for discussion, debate and other parliamentary procedures at a later time during the business session of the convention. Each side, "For and Against", the resolution, will be allowed three speakers. At the call of the Resolution Chairman the delegates will then vote on the resolution all pursuant to Robert's Rules of Order.

**WHEREAS**, Bishop Tod Brown received his primary education in Northern California then attended Ryan Preparatory Seminary in Fresno; attended St. John's Seminary in Camarillo earning his Bachelor of Arts degree; studied in Rome at the Pontifical North American College and the Pontifical Gregorian University earning a Bachelor of Sacred Theology degree; and earned a Master of Arts degree in biblical theology and education from the University of San Francisco; and

**WHEREAS,** Bishop Tod Brown was ordained a priest on May 1, 1963 by Bishop Aloysius Joseph Willinger for the Diocese of Monterey-Fresno; and

**WHEREAS**, Bishop Tod Brown, as a priest, served the Diocese of Monterey as a Parochial Vicar, Pastor, chairman of the Divine Worship Commission, chairman and member of the Presbyteral Council and Priests Pension Committee, member of the Diocesan Board of Education, chancellor, curial moderator, and Vicar General; and

**WHEREAS**, Bishop Tod Brown was appointed as the sixth Bishop of the Diocese of Boise (Idaho) on December 27, 1988 by Pope Saint John Paul II and was consecrated on April 3, 1989 by Archbishop William Levada with Bishop Brown assuming an episcopal motto of "Come Lord Jesus" (Revelation 22:20); and

**WHEREAS**, Bishop Tod Brown was appointed as the third Bishop of the Diocese of Orange on June 30, 1998 by Pope Saint John Paul II; and

**WHEREAS**, Bishop Tod Brown served within the United States Conference of Catholic Bishops as chair of the BCEIA Subcommittee on Interreligious Dialogue; was on the committee for Orthodox-Roman Catholic Bishop's Dialogue and the Pontifical Council on Interreligious Dialogue; and was a chairman of the Laity Committee and the Committee on Ecumenism and Interreligious Affairs; and

**WHEREAS**, Bishop Tod Brown led the Diocese of Orange's 2011 purchase of the Crystal Cathedral in Garden Grove in bankruptcy court from Robert Schuller Ministries to provide increased facilities to accommodate the population which had doubled during his tenure as bishop; and the facility was later renamed Christ Cathedral which was consecrated as the seat of the diocese in 2019; and

**WHEREAS**, Bishop Tod Brown's resignation as Bishop of Orange was accepted by Pope Benedict XVI on September 21, 2012 as he had reached retirement age; and

**WHEREAS**, Bishop Tod Brown was a member of Father Peter J.J. Juba Council 4922 and El Camino Real Assembly 85, having been an Honorary Life Member of our Order since June 1972; and

WHEREAS, Bishop Tod Brown entered eternal life on October 15, 2023 at the age of 86.
