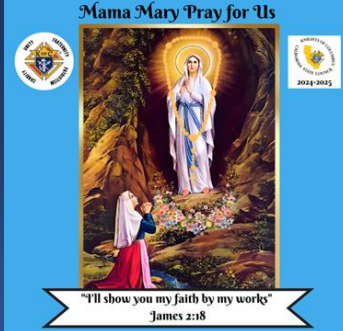

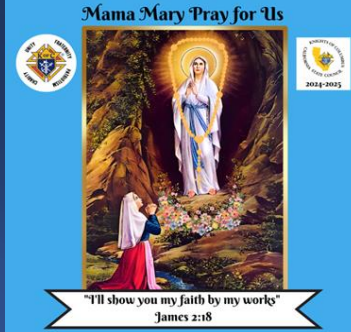

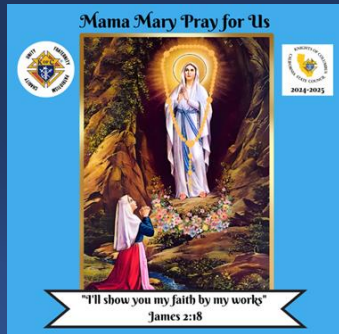
Resolutions

- All council resolutions, petitions, recommendations and proposed amendments to the State Council by-laws must have their original resolution into the state office postmarked no later than **Saturday, February 1, 2025**
- Council resolutions must be dated, signed by the council Grand Knight and Recorder and have the council seal affixed.

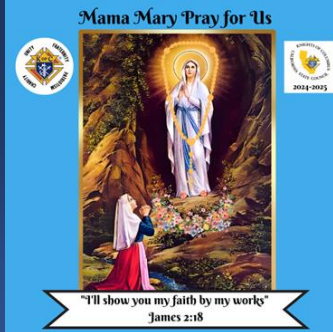
Resolutions

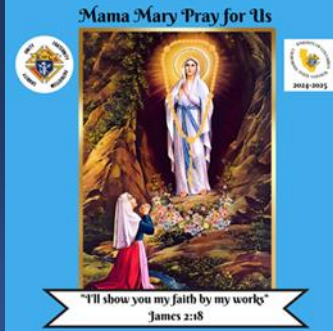
Home Corporations

- Home corporations are independent legal entities formed under the applicable laws of the jurisdictions in which members of local councils are situated. They are **NOT** subordinate units of the Knights of Columbus.
- The Home Corporations, and **not the Knights of Columbus**, are solely responsible for all liabilities arising from the properties and the activities conducted there.

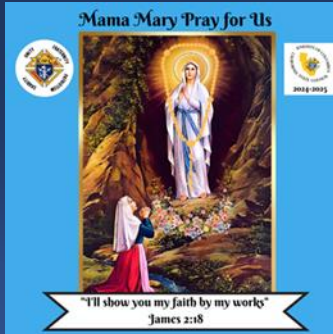
Home Corporations

- Councils using home corporation facilities are required to enter into written agreements governing:
 - (1) a council's use of home corporation facilities (the "terms of use agreement"); and
 - (2) how matters will be settled between the council and the home corporation in the event the home corporation IS DISSOLVED (the "charitable distribution agreement").

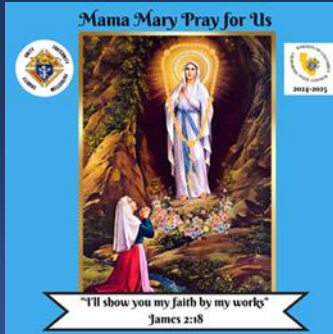
Council Liability

- Knights of Columbus does not provide insurance for local councils
 - Each council must arrange for its own insurance coverage
 - Knights of Columbus does not provide insurance for home corporations
 - Dioceses often require proof of insurance for councils using their facilities, and be named on the rider
 - Diocesan requirements often specify particular coverages and limits

Council Liability

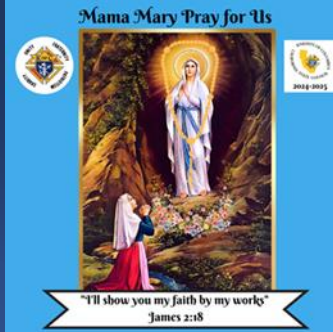
- **DESIRED PROTECTION INCLUDES:**

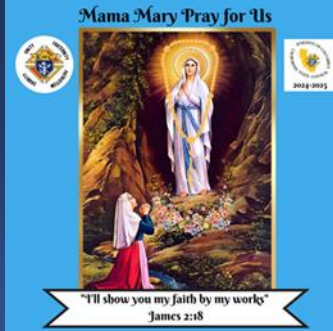

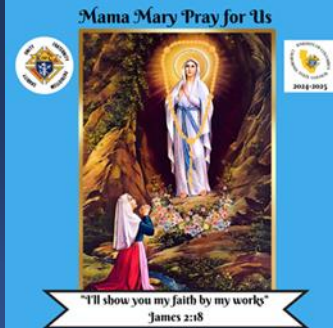

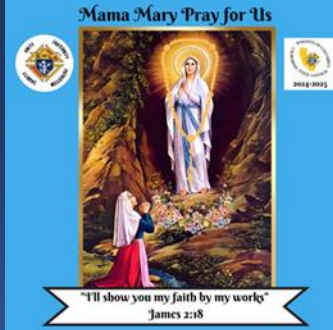
