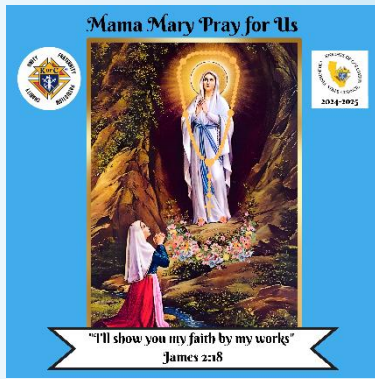

Star Council Progress



To Reach Star Council, by 12/31/2024, your Council should be...

- **Fully Compliant with Safe Environment.**
- **The Council should be at 50% of growth goal.**
- **The Council should be Compliant with all forms including 1295, 185, 365.**
- **The Council should have completed at least 1 FBE with at least 7 members present.**
- **The Council must be Active and not Suspended due to unpaid dues.**

Star District Progress



For Star District, the DD ideally should be monitoring council efforts and...

- **The District should be at 50% of goal for the District as of 12/31/2024.**
- **The DD should know which Councils are on track to make Star Council.**
- **Need to achieve 70% of growth goal by end of Fraternal Year.**
- **Need to achieve the Founders Award (FBE)) by at least 50% of the Councils.**
- **Need at least 1 Council to earn Star Council.**
- **File a 944 for every Council in the District.**
